All students are responsible for the tuition and residential fees listed for the 2020 – 2021 academic year. Fees are reviewed annually and periodically adjusted as a matter of policy.

### **Application Fee**

A \$100 application fee must be submitted with the registration. This fee is non-refundable.

### **Registration Deposit**

A \$1,000 deposit must accompany the registration form. This fee is non-refundable.

### **Graduation Extension**

There is a \$500 fee for students needing to file an extension for completion beyond the 2-year projected matriculation date for either academic or financial reasons.

### **Payment Options:**

#### **Option #1: Full Payment of \$6,000 each year**

Pay \$1,000 deposit

Year 1: Tuition (\$5,000) minus 5% pre-pay discount (\$250) = \$4,750

Year 2: Tuition (\$6,000) minus 5% pre-pay discount (\$300) = \$5,700

#### **Option #2: Quarterly Payment**

Pay \$1,000 deposit

Year 1: Tuition (\$5,000) plus a 2.5% processing fee (\$125) = \$5,125

Four (4) quarterly payments of \$1,281.25

Year 2: Tuition (\$6,000) plus a 2.5% processing fee (\$150) = \$6,150

Four (4) quarterly payments of \$1,537.50

#### **Option #3: Monthly Payment**

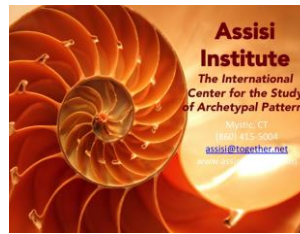

### Early Withdrawal/Refund Policy

Students enter a contractual agreement to complete the program for which they enroll. Decisions to withdraw early are a breaking of that contractual agreement. Refunds will be made for students whose accounts have been paid in full and who withdraw or are withdrawn from a program prior to the completion of that program. The initial deposit is non-refundable.

When a student withdraws from the Institute, he/she must compose a formal letter of early withdrawal and submit it in writing to the Assisi Institute Administrative Office. *The date from which refunds will be determined is the **last day of the module** during which the student submits a formal letter of withdrawal.* Refunds will be made within eight to ten weeks of the notification of an official withdrawal or date of determination of withdrawal by the Institute. The initial deposit is non-refundable. Refunds are calculated on the following scale:

Withdrawal within 30 days of Program Start: 80% refund (not including initial deposit)

Withdrawal within first three (3) months of Program Start: 50% refund

Withdrawal within first six (6) months of Program Start: 30% refund

There will be no refunds issued after six (6) months of Program Start
